### Vision Aligned Reporting (VAR)

The CA Community Colleges Chancellors Office is aligning program reporting to focus on critical outcomes identified in the <u>Vision 2030</u>, which expands and builds upon the Vision for Success and the <u>Governor's Roadmap</u>. Vision-Aligned Reporting (VAR) is an initiative from the Chancellor's Office for a new program reporting process focused on collecting only information that offers direct visibility into how program efforts impact student outcomes.

Starting in fall 2024, <u>Vision-Aligned Reporting</u> will launch with the following pilot programs: NextUp, CalWORKs, CCAP/Dual Enrollment, DSPS, EOPS, Middle College HS, MESA, SEA, Strong Workforce, Transfer Center, Veterans Resource Center. Several Gavilan staff attended a regional training on March 22nd to learn more about the reporting tool. Implementation team meetings will begin in April 2024.

## **Guided Pathways**

A Gavilan team attended the CA Guided Pathways Institute #6 in San Diego, CA from March 20th - 22nd. This was the last GP Institute for the colleges in cohort 2. The institute focused on sustainability of GP efforts and institutional best practices that transform the student experience to promote equitable outcomes in access, completion, and post-graduation success for students. # Educational Pathways/Dual Enrollment Lelannie Mann, Interim Director

Dual Enrollment staff are working with our HS partners to finalize the addition of more courses to our current CCAP agreements. The goal to align course selection with academic pathways so students can get a head start on their interest of study and general education. We are in discussions with Mt Madonna High school, part of Gilroy Unified School District, to initiate a pilot a CCAP agreement as well.

Counselors Jessica Weiler, Blanca Melchor and Outreach Specialist, Stacey Porteur, are scheduled to present to our Adult Ed students in the upcoming weeks.

# **Counseling Department**

- As of 3/20/24, counselors have completed a total 1048 graduation petitions
- 372 petitions for Fall 2023 graduation
- 676 petitions for Spring/Summer 2024 graduation

Staff have collaborated with Cal SOAP to provide Cash4College workshops at the following high schools:

We opened the application for students to request emergency financial assistance. To date, we have awarded more than 375 students with a \$500 grant.

Support Programs, including EOPS, CalWORKs, AEC, MESA, PUENTE and Athletics are supporting students with mid-semester progress checks that encourage faculty-student interaction and supportive measures from their counselor.

NextUp (a program supporting foster youth within EOPS) took 10 students on a southern California university tour on April 3-4th, during spring break.

- They visited Cal Poly San Luis Obispo, UC Santa Barbara and CSU Northridge. This overnight trip introduced students to various transfer university options that provide extensive support for foster youth.
- Students were accompanied by Fabian Pacheco, NextUp Counselor/Coordinator and Breanna Aguilar, EOPS Sr. Program Services Specialist.

# Student Health Services/Mental Health

The 1st Annual **Cesar Chavez Blood Drive** was held on March 26th. Thank you to ASGC and Athletics for co-sponsoring the event. Here are some highlights:

- Over 35 students, employees, and community members donated blood at this event.
- 54 people in total participated in the blood drive.
- According to the Stanford Blood Center, 116 lives impacted by the lifesaving donations collected at Gavilan College during this event.

## El Centro-Student Health Community Resource Fair

- Over 30 community partners provide resources to our students and employees.
- Santa Clara County Behavioral Health Substance Use Prevention Program was there with the alcohol/marijuana impaired googles to simulate sobriety tests and impaired driving.



### **Healthy Relationships Workshop**

 Student Health partnered with Community Solutions to facilitate a health relationships workshop that had over 110 students in attendance. Thank you to Diane Reid and athletics that brought their students.



# Mental Health First Aid Certification Training

- Mental health first aid certification will be taking place on April 19th AND May 3rd.
- This certification is similar to CPR and first aid certification but is based around recognizing signs and symptoms of mental health decline and ways to support individuals experiencing issues with mental health.
- Between these two sessions and the previous session, Gavilan will have nearly 75 employees and students trained as Mental Health First Aiders.
- Thank you to Jessica Weiler and Ryan Shook, two Gavilan employees already certified as mental health first aid instructors.




