# Board of Trustees Curriculum Summary October 9, 2018

## **Modified Courses**

ACCT 105 Payroll Accounting (Spring 2019), 3 Units, 3 Lec, 0 Lab Justification:

Non-substantial changes: (1) Adding Distance Education as a teaching method option. Students are requesting more and more DE courses. This teaching method also provides instructors, particularly part-timers, with the ability to teach without traveling to campus. (2) Advisory: Corrected math advisory course number from 205 to 430 and removed ACCT 101 as it is an inactive course. (3) Updated the textbook to the most current edition. (4) Reviewed SLO's and updated assessment date information. (5) Updated the content section by moving the homework listed to the Out of Class Assignments area.

ACCT 103 General Office Accounting (Spring 2019), 3 Units, 3 Lec, 0 Lab Justification:

Non-substantial changes: (1) The course is being renumbered from ACCT 203 to ACCT 103. SJSU will accept the course for those students who wish to minor in Business. For the articulation to exist, we need the course to be renumbered back to Accounting 103. (2) Adding Distance Education as a teaching method option. Students are requesting more and more DE courses. This teaching method also provides instructors, particularly part-timers, with the ability to teach without traveling to campus. (3) Updated textbook to the current year available and related textbook information.

AJ 100A Basic Police Academy (Fall 2013), 21 Units, 12 Lec, 37 Lab Justification:

Change only to number of Maximum Units. The calculation employed for the 18 week calendar revealed a mismatch in the number of maximum hours misaligned with the number of Units. No change in curriculum. No change in lecture/lab hours per week. No change in maximum hours. Just a correction in maximum Units to 30 to accommodate maximum hours.

BOT 281 Medical Billing (Spring 2019), 3 Units, 3 Lec, 0 Lab

Non-substantial changes: (1) Adding Distance Education as a teaching method option. Students are requesting more and more DE courses. This teaching method also provides instructors, particularly part-timers, with the ability to teach without traveling to campus. (2) Updated the textbook to the latest edition. These are the only changes being done to this course as it was just updated last year.

CSIS 26 Discrete Structures (Spring 2019), 3 Units, 3 Lec, 0 Lab Justification:

CSIS 24 Java Programming is being added as another option to satisfy the prerequisite.

In the C-ID, the course COMP 122 (Programming Concepts and Methodology I) is the prerequisite course for COMP 152 (Discrete Structures)
