## A. English 250 vs. 1A for GE for AA Degree

Fran distributed and reviewed survey handouts regarding English requirements at different community colleges. There was discussion on whether Gavilan should require English 250 or 1A for graduation. The English Department recommends that 1A be required. Leah suggests that the English Department develop options of ways to handle English 250 so Counseling Department concerns are dealt with. We are waiting for a Chancellor's Office ruling on 250 repeatability, which the English Department believes would be the best solution. Committee asked that Lozano bring these options to the next meeting, and then departments will discuss. Later this fall we will decide whether in light of new evidence and developments with 250 we should reconsider the GE English requirement.
