V. Issues

A. Discussion

1. Classes Taught in Spanish

Jesus Olivas reported that some students are being encouraged to register in transfer classes taught in Spanish that they are not academically prepared for. He also reported that the universities don't mind if courses are taught in Spanish as long as the rigor is the same as those taught in English. After discussion, it was agreed that if we offer a transfer course in another language, the rigor should be the same as the class offered in English, including any prerequisites. Enrique Luna inquired whether we are holding ourselves to the same standards and whether we have the structures in place for determining the overall support structure for the Spanish programs. He suggested that we insure that instructors have the required credentials and provide an equitable education. Sherrean reviewed the Adelante Consortium educational ladder of classes from Spanish Child Development classes through ESL and General Ed. She stated that the problem may be a supervisory issue. John suggested that the assessment done in Spanish be the same as the English assessment.
