- IV. Discussion
 - A. Service Learning Jesus Olivas/Leah Halper

 Best Practices Leah provided informational handouts (sent out as attachments to Curriculum Members) and a survey form. Discussion: Service Learning components as part of new and existing courses, with SLO's (re)written to include this type of activity for outcomes and method of evaluation. Denise reminds us that Communications 10 has included service learning for many years it is not new to Gavilan. Leah has 25 non-profit agencies willing to participate in a pilot program. Students would integrate course material with what is going on in the community, and write about their experiences. California History I & II and Sociology are courses that easily lend themselves to service learning. Not all sections of a course would have the service learning components. This is information that needs to be noted in the Class Schedule by section students should be aware of the possible time commitments in addition to regular class meetings. For Banner a positive note– this could be input into the Fall Schedule.
 - B. Credit for Military Service Dennie Van Tassel
 Discussion: Joy said this information has been in the Catalog for many years under
 "non-traditional credit". All our academic counselors are familiar with the forms
 required by the government and receive training in this area. This is not new for
 Gavilan-just new to the website. Leslie tells us that they have given this credit
 to veterans before, but it generally seems not to be to the students advantage. All
 cases are evaluated individually.
 - C. Double Counting of Courses Victor Krimsley
 Victor provided an excerpt from Title V, Section 55063, referencing the double
 counting of courses for satisfying general education requirements and a major or area
 of emphasis requirement. A discussion ensued, regarding interpretation of the

referenced Title V section versus current practice at Gavilan, and how counselors advise students on units/courses required to meet their goal of degree and/or transfer.

D. Banner Implications

1. Footnotes – Bonnie Donovan

Summer and Fall-Spring – Bonnie reminds the Curriculum Committee and the Department Chairs that a "Footnotes" page will not exist in the Banner Class Schedule. We have the ability to add footnote-type information as a comment at the section level or to the course description. She asks that the Department Chairs take the Summer and Fall-Spring Footnotes list and review the changes suggested by Cindy Starr – delete those that are redundant and state others more concisely. The remaining ones will be entered. Also, keep in mind that the one page of footnotes, when spread across multiple sections, will increase the size of the schedule.

2. Withdrawals – Erin, Susan and Victor have been working to update *BP* on Title V. The changes were sent out to Curriculum Committee members for them to review with

their representative group and will be an action item at the next meeting.

3. Course Repetition – Discussion: number of allowable course repetitions will be aligned with the Title V regulations – Leslie will revise the wording and send back to Victor – he will forward to the committee for review.
