- V. Agenda Adjustment Discussion
 - Library/Textbook Verification 3 methods: Librarian, publisher, "do-it-yourself" by checking grammar and spelling in MS Word (which is only good up to grade 12). Library uses Fry's scale for determination – goes up to grade 15-16. Alternative – cite usage by another college or university.
 - 2. Library resources double-check with Library so they can make sure resources are available for new or revised courses.
 - 3. Susan asked committee to think about discussion topics for Fall Semester.
 - 3. Victor suggested the need for a process for getting the programs approved by the Board to the Chancellor's Office. The program application should be written by the Department Chair with assistance from the Dean. Some have slipped through the cracks we have programs in the catalog not appearing on the Chancellor's List. We also need to use the forms provided by the Chancellor's Office Susan suggests a training session on the forms and the process. Victor will provide this at the next meeting. Counselors will need to know when this approval is official in order to best serve student needs and structure Ed Plans. Victor can create an administrative process for approval notification. These are also available for viewing on the Chancellors website.
