 - 1. MODIFICATION OF EXISTING COURSE FORM C
 - a. ART 10A Cultural History of Ceramics

Arturo stated this is a general update and the changes reflect the studio courses we now have. The assignments and the hours required for studio classes are now uniform.

Fran Lozano stated that currently students are putting in lab hours for which they get no unit credit. There was a question about this number of lab hours and are we collecting on them. Fran says yes.

d. ESL 521 Beginning ESL Listening/Speaking
Bea – ESL 521, 531, and 541 are the Listening/Speaking classes,
currently 4 lecture hours and 2 lab hours. Would like to eliminate 1 lab
hour - the new textbooks are coming with CD's for the extra listening
practice which can be done at home. Also, changing the advisory to
prerequisite – so the courses must be completed in order. Updating
content. This helps get the day and evening classes in line.

- f. ESL 531 Intermediate ESL Listening/Speaking I Same format as ESL 521 dropping 1 lab hour. Updating content. They have the required number of lecture hours.

- h. ESL 541 Intermediate ESL Listening/Speaking II Same format as ESL 521, 531 dropping 1 lab hour. Updating content. They have the required number of lecture hours.

 MSC (M. Machado/J. Maringer) vote was unanimous.
- j. ESL 552 Advanced ESL Reading/Vocabulary I
 General update and changing advisory to prerequisite.
 MSC (M. Bumgarner/D. Young) vote was unanimous.
- k. ESL 562 Advanced ESL Reading/Vocabulary II
 There was a question about the need for the confirming research when changing advisory to prerequisite. Victor explained if the classes are in sequence, the research does not have to be done.

 This is reinstating a course. The recording studio is being remodeled
 and they would like this course to be ready when the studio is done.
