a. ATH 38 Baseball

b. AE 636 Adapted Physical Education General update and minor changes to the description. Modify from weekly to content format, update SLOs. Does not qualify for GE.

## 4. <u>MODIFYING EXISTING AA/AS DEGREE OR CERTIFICATE OF</u> <u>ACHIEVEMENT – FORM G</u>

a. AA Degree and Certificate of Achievement in Biological Science Adding courses to the list of electives. Total unit value remains the same; the additional courses give students more options. The Certificate is pending approval, but the degree is in the catalog.

b. Certificate of Achievement in Early Intervention Assistant Adding new certificate to existing program. Statewide initiative/grant-funded program. Courses are infused with the competencies that all Early Interventionists need. This packages everything into one certificate and puts Gavilan in the forefront of being able to offer this for teachers.

c. AA and Certificate of Achievement Medical Office Option Add more choices of math classes to replace BOT 160 (rarely taught) which is being deleted from both the degree and the certificate. Clarification on number of units for the (non-essential) Math 402 which is not a degreeapplicable course.

- a. Certificate of Proficiency in Theatre & Television Television Degree Remove verbiage "Television Degree" (this is a certificate). Clean-up language and clarify the pathway as it is confusing.

- b. Certificate of Proficiency in ESL Intermediate Level
- c. Certificate of Proficiency in ESL Advanced Level

Kathy Campbell stated that the ESL Certificate of Achievement at the Intermediate and Advanced level was already approved. However these classes are Basic Skills and need to be less than 18 units and changed to Certificate of Proficiency. Certificate Units reduced: Intermediate to 12 units, Advanced to 14 units.
