    - 1. NEW COURSE PROPOSAL – FIRST READING
      - a. CSIS 13 MIPS Assembly Language Programming  
Dennie – this will allow us to teach two different programming languages.

      - b. CSIS 39 Objective C Programming  
This is a program that is used in iPods – very popular for applications for iPods.  
LEH = .70 and will be corrected on the 2<sup>nd</sup> reading.

3. MODIFICATION OF EXISTING COURSE – FORM C

- a. Adaptive PE Courses  
Gives Adapted Physical Education courses their own subject code (different from general Physical Education).

- b. AJ 179P Juvenile Counselor Core  
Linda Mirch – the content is not changing; added 16 hours for hands-on training. Research indicates that the normal number of course hours is 176 (not the current 160). Adding these to lab hours.

- c. AE 600 Vocational Training I
- d. AE 602 Vocational Training III  
General updates – on the list to be updated.

Dionne Clabaugh – put into 16-week format, change some of the objectives to align with the Early Intervention Certificate, add some very clearly stated advisories for counselors and students. ( Ex: must have taken CD 30A before enrolling for CD 30B, as 30B is an obvious extension of 30A and the foundation for 30B.) Discussion: if left as an advisory, a student could enroll in 30B without taking 30A. Should this be a pre-requisite or an equivalence? Instructor is placed at a disadvantage. The hope is to guide students into the proper path of courses in order to build the foundation of knowledge.

- i. CGD 9                      Advanced Computer Graphics for Design Application II  
Updated program to reflect changes in technology, to reflect transfer requirements, and demands of the job market. Teaches computer animation, ergonomics, adds sustainability.

**MSC (M. Bumgarner/D. Van Tassel) Vote: unanimous.**

- j. CGD 30                      Introduction to Environmental Design  
Changes/Update – include environmental analysis and preparation for 4-year colleges and careers. Students use technology that represent their designs.

- k. CGD 110                    Computer Graphics Lab  
Updates to language, updates courses feeding into the lab.

**MSC (D. Young/B. Lawn) Vote: unanimous.**

- l. CGD 160                    Technical Desktop Publishing/Graphics  
Creates class for students to develop presentations and use state of the art technology and programs. Number of lab hours was questioned. Regarding textbook – change to “recommended but not required.”

- m. IT 115                      Introduction to the Construction Industry  
Expand content to reach a broader audience. The abbreviated title was questioned (Intro to the Cons. Ind.). The textbook is about 8 years old and not updated very often.

- n. PE 33                        Walk/Run for Fitness  
On list of courses to be updated.

Statewide effort among 30 institutions. Blanket degree approved at the Chancellor’s Office. It will be part face-to-face and part Distance Ed. If we don’t get the enrollment, we can refer students to a number of institutions for other courses. This is separate from, and does not take the place of the Marketing Management degree. The Business Communications class is available and active – could be added as an alternative choice. The AA is 32 units plus the GE units. Certificate has 32 units.
