Information: A faculty member had concerns - the forms are unfriendly and daunting. A vertical format would allow for easier cut-and-paste to complete the forms. Erin commented that the cutand- paste format might be easier to complete, but the current format was easier to read - which was a greater concern for her. Jane asked: Could the text fields be formatted to word-wrap? The Committee will review the forms, but as these are public record documents, we want them to have a professional look.
