B. Cross-listing and Uncross-listing Courses – Discussion

S. Dodd provided the committee with a handout that provided a historical review of curriculum minutes regarding criteria for cross-listing courses. She provided an example from her department where by cross-listing KIN 6 with CD 6 allows for the course to have enough enrollment to carry, otherwise it would not be able to be offered. A. Rosette reviewed his department's position. It was suggested that a file be maintained which tracks cross-listed courses, the reasons why they were cross-

listed, who's department the course is housed in; and if they then become uncross-listed, the reasons for that. A. Rosette also suggested that an alternative to cross listing a course is for departments to be willing to list other disciplines courses in their programs. R. Sharboneau is concerned about using the same course number when courses become uncross-listed and are developed into new courses. She would like to see a procedure/policy in place to address making sure the same number is not reused as it is confusing to the students. S. Dodd, E. Venable, B. Donovan, and K. Rose will meet over the summer to develop some guidelines for cross-listing and/or uncross-listing courses that can then be carried forward to the curriculum committee in the fall.

1. <u>NEW COURSE PROPOSAL – FIRST READING</u>

a. MATH 242 Algebra II for Statistics

This course is recommended to students with majors that require NO mathematics beyond freshman level statistics (Math 5), and is NOT intended for students majoring in math, science, computer science and business. This course is intended to be a prerequisite for Statistics. Susan thanked the math department their efforts at continuously evaluating their curriculum and making modifications and/or developing new curriculum based on improving student success.

2. MODIFICATIONS TO EXISTING COURSES – FORM C

BUS 190, CARP 290, CD 190, CGD 190, COS 290, CSIS 190, CWE 190, CWE 192, CWE 290, DRTL 290, JOUR 190, MGMT 190, MKTG 190, MUS 190, WTRM 190 Reason for reactivation: As you recall, our committee approved a conversion of the CWE classes from 190 to 190 A and B, to allow for an additional level of courses to address potential repeatability issues. We have since learned that repeatability is not an issue for these courses. Additionally, we have determined that splitting these courses will result in problems in tracking the total number of units which in this case cannot exceed 16 overall.

Whereas, Susan Dodd has served as Curriculum Committee Chair since the Spring Semester of 2005.

Whereas, during her tenure as such, Susan confronted head-on many issues with college-wide impact in terms of curriculum: the transition to a 16-week calendar, the new emphasis on assessment of learning outcomes, the discussion of college-wide issues such as the cultural diversity requirement and the prerequisite establishment process, and the approval of associate degrees for transfer, which has garnered nine degrees so far.

Whereas, from the onset, Susan set about bringing clarity, timeliness, and openness with respect to curriculum. She created a technical review subcommittee to allow the full committee to focus on the broader aspects of the curriculum, kept a full calendar of meetings with attention to all required updates and deadlines, and created a monthly electronic newsletter to keep the faculty abreast of curriculum news and changes.

Whereas, Susan always made herself available to work with faculty in a variety of ways both to answer questions and assist instructors with any curriculum issues. Susan always modeled the curriculum work and led by example, so Athletics and Kinesiology courses were usually the first ones to be submitted for updates. In this way, Susan could experiment with the forms and show others that the rather unwieldy assignment *could*, indeed, be done.

Resolved, the Academic Senate commends Susan Dodd for her firm and steady leadership as chair of the Curriculum Committee, for her unshakable belief that the Gavilan College faculty can rise to any challenge, and for her tireless dedication to all matters curriculum.
