- I. Call to Order: Welcome @ 3:05 pm.
- II. Agenda adjustments and approval

MSC (S. Sandler/P. Yuh). All in favor. Agenda approved as corrected.

Item V. e. was corrected to reflect ENGL 12C. Under Course Modifications, Item V 1. ESL Advanced Level NC Certificate of Competency and ESL Intermediate Level of Competency were removed from the agenda. Item VI. 5. New Course – Second Reading, Bio 2 course name was changed to Organismal Biology. Item VI. 6. Liberal Arts and Sciences-A.S.-T Degree was changed to second reading.

III. Approval of Minutes for November 26, 2018

MSC (C. Oler/S. Sandler). All in favor. Minutes approved as presented.

Approval of Minutes for December 10, 2018

MSC (N. Dequin/S. Sandler). All in favor. Minutes approved as corrected.

- IV. Information/Discussion
 - 1. Guided Pathways: status of workgroups: Leslie Tenney and Rosa Sharboneau
 - L. Tenney announced that the Curriculum Committee meeting schedule has been updated and is on the Curriculum website. R. Sharboneau provided an update on the work of clustering Meta-Majors. Data was collected for the majors from faculty, staff, Gavilan students and high school students and is currently being analyzed. The data will be reviewed, over the next few weeks, with students' perspective in mind in order to ensure student success. Based on analysis of this data, the Meta-Majors Workgroup will provide a recommendation that includes three models for further review in April.

The mapping of ADT's is near completion and L. Tenney relayed that she hopes to have the packets distributed to Department Chairs soon so they can take them back to their departments for review. The next step is to consolidate the maps for ADT's to include both a counseling and instructional perspective by March 15. The goal is to market and pilot

some of these programs for the 2019 fall semester.

2. AB 705 and update re: tutoring apportionment: Denee Pescarmona

D. Pescarmona reported on tutoring apportionment for AB 705. The English Department, Math Department, ESL and the Counseling Department have been collaborating to develop strategies in order to support students through their first year with direct placement. Language around how we collect apportionment for tutoring has changed with relation to AB 705. The scope of what we can collect apportionment for has been expanded to cover four categories: quantitative reasoning, qualitative reasoning, written and oral communications, and mathematical concepts. D. Pescarmona will forward the Chancellor's Office memo concerning collecting apportionment to Department Chairs. She recommended that Department Chairs review it for future discussions.

3. Accreditation review and expectations: Denee Pescarmona

D. Pescarmona communicated that the accreditation team visit will be at Gavilan College March 11 through March 14. She also distributed an Institutional Self-Evaluation Report (ISER) quick reference guide which covers standards one through four. Some members from the accreditation team will be attending the Curriculum Committee meeting and D. Pescarmona recommended that everyone try and arrive on time. She recommended that Department Chairs review processes and section II A. of the ISER which relates to the work of the Curriculum Committee. The accreditation team will likely speak with some of the Department Chairs.

There will be some open forums during the accreditation team visit. The first will be held Tuesday, March 12 at 11 am and the second will be held Wednesday, March 13 at 5 pm. All are welcome to attend the forums. D. Pescarmona also relayed that the commission's new focus is on continuous quality improvement. She also suggested Department Chairs alert their faculty that accreditation team members, wearing a badge, may be visiting classrooms. One area mentioned for potential clean up in CurricUNET is Distance Education (DE). Many tabs are blank. P. Howell and S. Lawrence are reviewing these courses in CurricUNET and may be reaching out to individuals.

4. ESL Course Flow Chart & Course Mirroring: Nicole Cisneros & Denee Pescarmona

N. Cisneros reported on her work mirroring classes for credit and non-credit. She also distributed an acceleration flowchart for the mapping of ESL classes. The advantage of mirroring classes is that instructors can teach both a credit and non-credit course within one course.

A discussion ensued regarding the implications of mirrored classes. Items related to this issue still need to be negotiated and a member questioned the impact on faculty. Other questions for mirrored classes remain regarding methodologies and class structure. Noncredit courses have to fit adult education categories. Another question was raised as to when a course is a good candidate for mirroring. Standards and requirements are the same with the mirrored courses. Enrollment of has increased in English 250 and English 260 for students finishing up in ESL . D. Pescarmona informed the committee that the program review process will include evaluating these mirrored courses.

5. New DE Checkbox/Functionality and process: James Ghiorzi

J. Ghiorzi addressed the issue related to new and modified courses in DE. Enhancements have been made to CurricUNET and they currently apply only to the new and modified courses within DE. Once the Distance Ed box is checked off then portions will have required areas for completion. J. Ghiorzi reminded the committee to hit the save button once completing the information. The Distance Course Accessibility Agreement link has also been fixed. If the Distance Ed button is checked, S. Lawrence and P. Howell will review the new and modified courses and may send it back to the originator if necessary.

Pescarmona relayed that there will be minimal impact due to the number of students enrolled in the ESL 500 courses. For ESL 569, the justification should be changed to 8 units. N. Cisneros will change it.
