Equity funds were used to employ a part-time EOPS/Foster Youth Counselor during the 2015-16 year and this year we were able to hire a FT EOPS/Equity Counselor (hired as of 11/9/16) with half the funds coming from Equity and half from EOPS to increase Foster Youth participation in EOPS and provide supportive services to Foster Youth who are not eligible for EOPS. Since hiring our FT Counselor we have also extended supportive services to AB540 students.

- 2. Describe how you provided outreach to the target groups? Sent letter and e-mail to all foster youth enrolled to advertise the available support. Created flyers and developing a brochure for Gavilan foster youth to raise awareness of available support and services. Also participating in Santa Clara and San Benito County Foster Youth Success Liaison meetings to maintain awareness of community resources and link to Gavilan College for incoming students.
- How has this activity been captured in your program plan? This activity is tied to one of program plan's objectives to enhace support and services to both Foster Youth and AB540/Dreamer students. Increasing
- Do you have modifications for your plan? The only modification has been the inclusion of AB540/Dreamer students as part of our Equity funded efforts to provide outreach and awareness of available support.

In addition to serving Foster Youth as stated in the Equity plan, the funds used for our FT Counselor are also supporting AB540 students. There are twise as many AB540 students as there are Foster Youth at Gavilan who need a similar type of support. Tracking mechanisms for enrollment, persistence and number of students served are in development through ARGOS and SARS.

Our FT Counselor was only recently hired as of Nov. 9th, 2016. Tracking mechanisms for data gathering were not in place and are being developed. More data should be available to report by the end of Spring '17.
