Vision/Narrative

The philosophy of the Gavilan College Nursing Program is based up a set of beliefs shared by the total nursing faculty. The nursing faculty believes that nursing encompasses a broad occupational field involving a variety of functions performed by individuals with varying levels of preparation. So, to this end, the faculty agrees upon the definition of nursing: Nursing is a science, which entails goal-oriented action to provide direct or indirect care to individuals, families, groups, and communities. The essence of nursing is the interpersonal process through which the nurse assists to identify alterations in the client's ability to provide self-care. The nurse guides the client to establish responses, which will modify, reduce, or prevent health problems (self-care deficits). In addition, these nursing actions enable the individual to achieve optimal health. The Gavilan College Allied Health Program includes Certified Nursing Assistant, Home Health Aide, Clinical Medical Assisting, Person in the Life Span, Nutrition, Licensed Vocational Nursing, Registered Nursing, general education and transfer courses and continuing education for health professionals. The Allied Health staff are committed to the goal of providing every student with the opportunity to become prepared for the world of work with the acquisition of marketable skills necessary for suitable employment and life-long learning leading to career advancement.IEC PROGRAM REVIEW SUMMARY Academic Year 2011/2012Major Program Goals:Reduce or eliminate the waiting list for 1st and 3rd year of the RN program. Meet or exceed the state or national standards on licensing exams. Increase simulation in each clinical course offering. Provide nursing skills lab hours for remediation. Maintain and upgrade technology and equipment to current industry standards. Continue to recruit and hire qualified faculty both full and part time. Concerns/Trends: Applicants exceed available admissions. Demand for pre-requisite courses exceeds available sections. Challenge in recruiting replacement and part time faculty. Lack of sufficient clinical placement sites. Increased costs of clinical instructional materials. Students' need for remediation of basic nursing skills. Plans for Addressing Concerns/Trends:Consider eliminating the waitlist for the RN program so that students only have to apply once at the LVN program entry and then transition directly into the RN program. Increase the State Board NCLEX pass rate for the RN course. Mentor younger faculty so that they might fill full-time positions as they become available. Continue to upgrade technology and its use in instruction. IEC Recommendations: Continue collaboration with the Natural Sciences department and the VicePresident of Instruction to insure student prerequisite are offered in adequate number and in proper sequence. Examine feasibility of eliminating the RN waiting list. Further the collaboration with Bachelor's of Science in Nursing programs at CSUs. Current status:Progress has been made in all areas designated major program goals. The first group of students enrolled in the cooperative program at CSUMB will graduate with a BSN degree in summer 2014. Additional funding from the Rupe Foundation has increased the certified nursing assistant enrollment and funded two sections of home health aide per semester. We understand that there is a need for additional classified personnel.
