9.2 Approval to Spend Up To \$25 \$75 on New Scantrons from the Book Store, Daniel Chavez, Senator of Technology (5 min)

MSC (D. Chavez) Communications Studies 4 (Intercultural Communications) has thirty-two students in each class and two sections in Fall 2017. Communications 8 (interpersonal Communication) has thirty-two students in each class and three sections in Fall 2017. Both classes have two exams. Total 160 students. Proposed to allocate 50 scantrons initially and \$20 each minus 20% bookstore discount plus 9% tax. Total cost would be \$17.44. <u>\$20 is being requested.</u> It is suggested to bump up to 150 scantrons. Amended to strike \$25 and insert \$75 Approved unanimously with amendments
