In 2004 approved a bond. We're currently an apportion-based district. Very strong possibility that we'll change to a funding based off of property taxes, basic aid funding. Another big piece is our new educational master plan, as well as a facilities master plan, forecasting for new facilities as we grow. We can do some really big dreaming, some really big planning. General obligation bond is an opportunity for us to grow with our community. The public would pay a certain amount of money per 100,000 of their home. It can be recalculated as a tax break for many local homeowners. Any other questions about the general obligation bond can be discussed Jan 9th, open workshop for the public on the bond timeline, or directed to Dr. Rose herself
